The American Funds Balanced Ret Acct is a Separate Account Sub-Account maintained by TFLIC and invests exclusively in the American Funds Balanced Ret Opt, a Transamerica Life Insurance Company (TLIC) Separate Account. The TLIC Separate Account invests in the American Funds Balanced Fund (Class R-5 Shares), a mutual fund (Fund). Prior to 05-14-10, the underlying TLIC Separate Account invested in the Class R-3 Shares of the underlying mutual fund.

Investment Objective & Strategy

The investment seeks conservation of capital, current income and long-term growth of capital and income.

The fund uses a balanced approach to invest in a broad range of securities, including common stocks and investment-grade bonds. 
